It is critically important for the business community, policy makers, innovators and investors to understand the importance of supply diversity in our pursuit toward mitigating the negative impacts of climate change. H2FA will make a clear statement of this commitment to its stakeholders and the general public.

Our commitment is as follows:

Hydrogen Fuels Australia (H2FA) is an Australian industry pioneer in the development of renewable modular hydrogen fuel generation with integrated refuelling facilities. We are launching Australia's first integrated modular hydrogen fuel generation and refuelling operation at our greenfield facility in Truganina, Victoria – 20km west of the state capital, Melbourne.

Founded on environmentally sustainable and low impact concepts, our operation uses electrolysis assets to convert renewable energy into green hydrogen. H2FA's facilities will not be connected to the main electricity grid and will rely on circular power generation. Our goal is to achieve 100% self-sufficient zero-emission fuel.

Hydrogen Fuels Australia (H2FA) vision is to help drive a change in Australia's energy sector by producing environmentally friendly Green Hydrogen from renewable energy and distributing this clean energy source via a network of modular Hydrogen Refuelling Stations (HRS) throughout Australia. Utilising a staged roll out will both compliment and stimulate the anticipated growth in hydrogen demand as Australia accelerates its inevitable move to decarbonisation.

H2FA's mission is to establish itself in the Australian hydrogen industry by satiating growth forecasts for hydrogen usage in the heavy vehicle fuel industry and simultaneously make Green Hydrogen commercially available to other end users with a threefold strategy:

1. **Production** of Green Hydrogen with a highly competitive Levelised Cost of Hydrogen (LCOH)
2. Excellence in Green Hydrogen **distribution and validation** with digital integration
3. Establishing best in class **modular Hydrogen Refuelling Stations** in key locations

Our vision and mission coincide with a global surge in ethical and sustainable investment patterns which we believe will help shape humankind's future for generations to come. We strongly believe Green Hydrogen can reshape Australia's energy sector.

We commit to annually submitting our progress towards enabling and consuming low carbon hydrogen to the World Energy Council.
